WHILE ENROUTE, EIGHT TOTES EACH CONTAINING LIQUID SHIFTED WHILE IN TRANSIT, CAUSING THE ENTIRE TRAILER TO TIP OVER 2 OF THE 8 TOTES WERE FOUND DAMAGED AND LEAKING. AN EMERGENCY RESPONSE TEAM PERFORMED THE CONTAINMENT, CLEAN UP AND PROPERLY DISPOSED OF THE TWO TOTES, ALONG WITH CLEANUP AND AFFECTED MATERIALS. THE REMAINING 6 TOTES WERE FOUND OK AND WERE FORWARDED ONTO DESTINATION.

INSPECT AREAS THOROUGHLY TO ENSURE UNSAFE CONDITIONS ARE NOT PRESENT TO AVOID EASY DAMAGING TO DRUMS, PAILS, TOTES, BAGS AND OTHER PACKAGING CONTAINING HAZARDOUS MATERIALS OR CHEMICALS. PAILS, BAGS, TOTES AND DRUMS OF LIQUIDS, CHEMICAL AND HAZARDOUS MATERIALS MUST BE PROPERLY BLOCKED AND BRACED TO PREVENT LOAD SHIFTING AND PALLETS AND OR AIRBAGS TO PROPERLY SHROUD, BLOCK, BRACE AND SECURE FREIGHT AND THE ENTIRE LOAD. RETRAINING IN PROPER AND SAFE LOADING OF HAZARDOUS MATERIALS AND CHEMICAL FREIGHT, USING PROPER AND SAFE BLOCKING AND BRACING LOADING TECHNIQUES.
