TRUCK WAS EASTBOUND, CLEAR AND DRY WEATHER CONDITIONS. ON A DOWNHILL GRADE, DRIVER ENGAGED HIS ENGINE BRAKE. TRUCK BEGAN TO BOUNCE, THEN WEAVE INTO THE OPPOSITE LANE. DRIVER CORRECTED TO AVOID ONCOMING TRAFFIC, CAUSING LIQUID LOAD TO SHIFT. DRIVER AVOIDED ONCOMING TRAFFIC, BUT LOST CONTROL. OVERTURNING THE TRUCK ONTO THE HIGHWAY GUARD RAIL. CONTACT WITH THE GUARD RAIL PUNCTURED TWO OF THREE COMPARTMENTS OF THE CARGO TANK, RESULTING IN SPILLAGE OF PRODUCT. WITNESSES NOTIFIED HIGHWAY PATROL AND ENGAGED BACKHOES TO BUILD DIKES TO CONTAIN SPILLED PRODUCT NEAR THE HIGHWAY RIGHT OF WAY. STATE PATROL, LOCAL LEPC AND ENVIRONMENTAL CONTRACTOR WERE MOBILIZED TO EVACUATE THE INJURED DRIVER AND CLEAN UP THE SPILL. TRUCK WAS REMOVED AFTER REMAINING PRODUCT WAS PUMPED OFF. AFTER REVIEW OF THE INCIDENT, AND NOTWITHSTANDING CLEAR CONDITIONS AND BEING WITHIN THE SPEED LIMIT, I CONCLUDED THAT THE DRIVER WAS DRIVING TOO FAST FOR THE CONDITION OF THE ROAD
