Employee was driving a chemical body load truck on I-220 west bound. Employee had entered construction zone. Third party came to a stop and the employee swerved to miss the third party. When vehicle left the roadway vehicle rollover and then back on to its wheels. When vehicle rolled over 4 of the 8 totes carrying MO-67 (sodium hydroxide) leaked there contents on the the ground. Damage to the totes varied but 3 of the 4 sustain cracks down the body of the tote.
