DRIVER SUFFERED APPARENT HEART ATTACK. LEFT ROADWAY, CROSSED MEDIAN, CROSSED OPPOSING LANES OF TRAFFIC, AND CROSSED AREA BETWEEN ROADWAY AND EXIT RAMP, THROUGH A GUARDRAIL AND OVER AN EMBANKMENT WHERE UNIT OVERTURNED. PRODUCT ESCAPED THROUGH THE DOME LID AS IT WAS JOSTLED IN THE OVERTURNING. THE TANK ITSELF HAD A CRACK IN THE FRONT LEFT SIDE OF TANK CAUSED, WE BELIEVE BY THE IMPACT OF THE OVERTURNING ON UNEVEN TERRAIN. THE INCIDENT WAS REPORTED TO LOCAL AUTHORITIES THAT IN TURN MOBILIZED A CLEAN-UP CREW AND SECURED THE SCENE AS BEST AS POSSIBLE UNTIL PRODUCT COULD BE REMOVED FROM TANK AND THE EQUIPMENT REMOVED FROM THE SCENE.
