THE MATERIAL TURNED OUT TO BE FERRIC CHLORIDE SOLUTION OF WHICH WAS NOT COMPATIBLE WITH THE STAINLESS STEEL CARGO TANK THAT WAS USED. THE ENTIRE CONTENTS OF THE CARGO TANK WAS RELEASED ONTO THE GROUND. THERE IS AN EXTENSE CLEAN UP PROCESS TO REMEDIATE THE AREA OF CONTAMINATION THAT IS STILL BEING DONE AS OF 8/10/94. THE SPILLED MATERIALS WILL BE DISPOSED OF IN ACCORDANCE WITH ALL REGULATIONS.
