TRACTOR TRAILER IS TRAVELING ON RT. 476 TO JOB SITE. DRIVER GOES AROUND CURVE AND STATES THAT THE STEERING LOCKS UP ON THE TRUCK. THE TRUCK GOES INTO THE DITCH AND THE DRIVER STATED THAT THE STEERING STARTED TO WORK AGAIN. HE GOT THE TRUCK OUT OF THE DITCH BUT THE TRAILER TRACKED INTO THE DITCH. THE TRAILER THEN OVERTURNED AND TURNED THE TRUCK OVER TOO. WHEN THE TRAILER OVERTURNED IT CAUSE A CREASE IN THE FRONT CORNER, WHICH CAUSED A SMALL HOLE. WE PATCHED THE HOLE, HOWEVER WE STILL LOST 131.5 GALLONS. THE TRUCK WAS A 2012 MODEL T-800 KENWORTH WITH 24,000 MILES ON IT. WE ARE IN THE PROCESS OF HAVING THE POWER STEERING CHECKED ON THIS TRUCK.
