ACCORDING TO THE INFORMATION OBTAINED, THE FOLLOWING OCCURRED. WHILE UNLOADING, FREE PRODUCT WAS DISCOVERED LEAKING FROM THE TRAILER. HAZMAT ONE OF OLATHE, KANSAS DISPATCHED ENVIRONMENTAL RESTORATION OF SAINT LOUIS, MISSOURI TO PERFORM THE CLEANUP. UPON FURTHER INVESTIGATION, ONE LEAKING THREE HUNDRED GALLON PLASTIC TOTE WAS DISCOVERED INSIDE AN ALUMINUM FRAME ON A WOODEN PALLET INSIDE THE TRAILER. APPROXIMATELY ONE HUNDRED AND FIFTY GALLONS OF FREE PRODUCT WERE RELEASED AND CONTAINED TO THE ASPHALT. THE RELEASE WAS DUE TO A PUNCTURE TO THE BOTTOM OF THE TOTE BY A NAIL ON THE PALLET. ENVIRONMENTAL RESTORATION GENERATED FOUR, FIFTY-FIVE GALLON PLASTIC RECOVERY DRUMS OF CLEANUP MATERIALS. THE REMAINING ONE HUNDRED AND FIFTY GALLONS OF PRODUCT INSIDE THE TOTE WERE PUMPED OUT AND PLACED INTO THREE, FIFTY-FIVE GALLON PLASTIC RECOVERY DRUMS. THE EMPTY TOTE AND ALL SIX RECOVERY DRUMS, ALONG WITH A STACK OF CONTAMINATED SKIDS, WILL BE HELD AT THE TERMINAL FOR DISPOSITION. THE REMAINDER OF THE SHIPMENT WAS FORWARDED TO THE CONSIGNEE. NO INJURIES OR EXPOSURES WERE REPORTED. THE MSDS WAS REQUESTED AND RECEIVED.
