Describe:

According to the information obtained, the following occurred. Neier, Inc. driver picked up approximately 5,000 gallons of sodium hydroxide solution, (25%), at shipper location, and proceeded to leave property. Upon exiting onto Redco Drive, free product sloshed from the dome cover, which had not been properly secured. Approximately 100 gallons of free product were released to the roadway and adjacent soils. Majority impacted private property, Heartland Kids Easy Learning Daycare Center, and resulted in business closure and road closures. Redco Drive and Ernestine Drive were closed as a result of the release, which resulted in various business closures due to limited access. The Marion City Fire Department and Illinois State Police responded to assess the site. Freeman Environmental of Herrin, Illinois was dispatched to perform the cleanup. Freeman Environmental neutralized the free product on the affected roadway, excavated the impacted soils from immediate area, and recovered residual contamination from two (2) nearby storm drains. Waste was containerized and transported for disposal in accordance with local, state, and federal regulations. There were no injuries or exposure reported.
