AT AN UNDETERMINED TIME, VANDALS OPENED THE BOTTOM OUTLET VALVES ON THREE TANK CARS CONTAINING METHANOL ON A PRIVATELY OWNED INDUSTRY TRACK IN FAIRBANKS, ALASKA. AT 2:30 A.M. ON DECEMBER 4, 1989, AN ARRC SWITCH CREW NOTED THE LEAKAGE AFTER MOVING THE CARS 250 FEET. (THE VANDALS DID NOT VENT THE CARS; CONSEQUENTLY, THE FLOW OF PRODUCTS DIMINISHED UNTIL THE CARS WERE MOVED IN THE SWITCHING OPERATION.) THE CREW IMMEDIATELY CLOSED THE VALVES AND NOTIFIED THE ARRC YARDMASTER OF THE HAZARDOUS MATERIAL RELEASE AND MOVED TO A SAFE AREA. SEVERAL NEARBY RESIDENTS AND BUSINESSES WERE EVACUATED FOR APPROXIMATELY 8 HRS. NO FIRE OR INJURY RESULTED FROM THIS INCIDENT; HOWEVER, APPROX 11137 GALLONS OF METHANOL WERE RELEASED AND ENVIRONMENTAL CLEAN UP ACCOUNTS FOR THE MAJORITY OF THE PROJECTED DOLLAR COST OF DAMAGES.

ON DECEMBER 4, 1989, AN ARRC SWITCH CREW NOTED THE LEAKAGE AFTER MOVING THE CARS 250 FEET. (THE VANDALS DID NOT VENT THE CARS; CONSEQUENTLY, THE FLOW OF PRODUCTS DIMINISHED UNTIL THE CARS WERE MOVED IN THE SWITCHING OPERATION.) THE CREW IMMEDIATELY CLOSED THE VALVES AND NOTIFIED THE ARRC YARDMASTER OF THE HAZARDOUS MATERIAL RELEASE AND MOVED TO A SAFE AREA.
