LOADING MOLTEN SULFUR ON INLAND BARGE FOR FLOATING STORAGE. AT THE END OF TRANSFER, BARGE TANKERMAN MISCALCULATED TANK FILL LEVEL; THUS CAUSING SPILL ONTO BARGE DECK. OVER-FILL STOPPED BY CLOSING DOCK EMERGENCY SHUTDOWN VALVE AND BARGE LOADING VALVES. MARTIN GAS SALES, INC. IN-HOUSE PERSONNEL PERFORMED CLEAN-UP ACTIVITIES WHICH CONSISTED OF RECYCLING 90% OF SPILL MATERIAL BACK INTO BARGE AND 10% CONTAINERIZED AND DISPOSED IN APPROVED LAND FIELD.
