Describe:

An employee of D & F Services was unloading an IBC from our trailer and did not have the forklift adequately under the IBC. While backing out of our trailer and across the dock plate, the IBC tipped over on its side and bursted open, spilling all the contents. The product went all over the inside of the trailer and leaked out onto the gravel parking lot at the consignee's facility. No waterways or storm drains were impacted by the spill. There was an evacuation of 150 feet in all directions as directed by Doug Barlet, Fire Chief on the scene.
