TRUCK LOST CONTROL, HITTING A ROCK WALL, AND COMING TO REST ON DRIVER SIDE. BOTH TANKS WERE PUNCTURED AND PRODUCT LOST. ENVIRONMENTAL DAMAGE TO DITCH. SPILLING MATERIAL HAULED AWAY. DEQ AND PRIVATE COMPANIES CLEANED SITE. ACCOUNT WITH DEQ OPEN, BUT THE SITE IS FINISHED.
