Describe:

As the tote was being loaded into a trailer, a protruding piece of metal on the trailer wall punctured the tote. Absorbent materials were immediately placed in the trailer and to the dock apron below the trailer to contain and absorb the released material. A professional cleanup contractor was immediately hired to neutralize and absorb the released material. The neutralized material was placed into overpack containers and staged on site for later disposal. Due to the hazard of material the package specifications were not able to be obtained.
