WHILE PUMPING OFF DIESEL INTO ABOVE-GROUND TANK, A DEFECTIVE VALVE ON CUSTOMERS TANK DID NOT OPEN UNDER PRESSURE, CAUSING THE DISCHARGE HOSE TO BUILD PRESSURE, AND CRACKED THE FITTING ON END OF HOSE. DRIVER WAS STANDING AT VALVE AND SHUT OFF IMMEDIATELY, CAUSING A LOSS OF APPROXIMATELY 160 GALLONS. SAND-PILE AT SITE WAS USED TO CONTAIN SPILL. SAND WAS TESTED (AQUATIC TOXICITY SCREEN), AND WAS RELEASED BY LOCAL SAN JOAQUIN ENVIRONMENTAL HEALTH, AND DISPOSED OF FORWARD INC. LOCAL LAND FILL (ATTACHED). VALVE WAS REPLACED ON CUSTOMERS TANK AND WORKS FIND.
