Hollywood Yard MYO reported a release of spent Sulfuric acid from tank car GATX 6558 that injured a Union Pacific conductor and was transported via ambulance to the hospital. After inspection of tank car GATX 6558 the quick fill port was not secured; swing bolts were less than tool tight which caused the release during switching operations. The quick fill port was secured and the car was cleaned and released to destination.
