TRUCK TRACTOR & TRAILER TRAVELING ON CANAL BLVD. WHEN UNIT ATTEMPTED A LEFT TURN TO THE ENTRANCE RAMP TO I-580. VEHICLE WAS GOING TOO FAST AND OUT TURNED ON TO ITS RIGHT SIDE. A VAPOR HOSE FITTING PUNCTURED THE #3 COMPARTMENT CAUSING ABOUT 1,500 GALLONS. TO ESCAPE THE ESCAPING FUEL RAN INTO A STORM DRAIN, SOME OF THE SPILLED PRODUCT WAS CONTAINED BEFORE ENTERING THE STORM DRAIN AND THE REMAINING PRODUCT IN THE STORM DRAIN. A SMALL TRACE OF THE SPILLED PRODUCT REACHED THE BAY AND WAS CONTAINED WITH A BOOM. NO INJURIES.
