Describe:

Trailer was in the process of loading and had approximately 4,106 gallons of material loaded when a section of the trailer ruptured. Area of rupture was approximately four feet wide and five feet long. Rupture ran along a vertical seam as well as two horizontal seams. Entire contents evacuated the trailer immediately. Internal emergency response team from Goodyear controlled the scene by applying fire fighting foam to prevent risk of ignition and provided clean up of product and collection of product and all water associated with the clean up operation.
