Driver pulled up to the Wholesale Fuels to off load low sulphur diesel. In filling up the tank it started to over flow out of the 2 inch stick the valves were reading that the tank was not full however it appeared after the investigation that the gauges were faulty, this was an above ground tank and site had a mix of fuel and water in the containment pit area. It was noted by my client Flying J that HMHTTC role in this job was to report the spill to the NRC as well as the state. An in house cleaning team responded in to the site for the clean up. no further information was given to HMHTTC other than how the incident occurred.
