THE KENAN TRANSPORT, LLC UNIT WAS TRAVELING NORTHBOUND ON NORTH CAROLINA ROUTE #86 IN HILLSBOROUGH, NORTH CAROLINA. THE OTHER VEHICLE WAS TRAVELING WESTBOUND ON STATE ROUTE 1545 AND FAILED TO STOP AT A STOP SIGN AND STRUCK THE RIGHT SIDE OF THE KENAN TRANSPORT, LLC TRACTOR. AS A RESULT OF THE COLLISION, THE KENAN TRANSPORT, LLC DRIVER LOST CONTROL OF THE UNIT AND IT WENT OFF THE ROADWAY AND OVERTURNED. THE TRACTOR WAS COMPLETELY CONSUMED BY FIRE AND THE KENAN TRANSPORT, LLC DRIVER WAS FATALLY INJURED. THE TRAILER CONTAINING 9400 GALLONS OF PROPANE WAS DAMAGED BUT THERE WAS NO PRODUCT RELEASED. A LOCAL HAZARDOUS MATERIAL CONTRACTOR RESPONDED TO THE SCENE AND ASSISTED KENAN TRANSPORT, LLC PERSONNEL IN TRANSFERRING THE PROPANE TO ANOTHER TRAILER. NO FURTHER ENVIRONMENTAL IMPACT IS ANTICIPATED.
