New driver trained on different tanker configuration was dispatched with tanker with different pump configuration. Driver hooked up hoses backwards on pump and opened valves to begin transfer. Customer tank had 4000 gallons of Xylene in it and this gravity fed back through pump and discharged from open valve on tanker to ground. Check valve inline that should have prevented back flow failed. Xylene rapidly evaporated due to 100 degree temperatures and no residue remained for cleanup.
