THE KAG WEST, LLC DRIVER WAS ATTEMPTING TO POSITION THE TRAILER TO MAKE A DELIVERY AT THE CUSTOMER LOCATION. IN THE COURSE OF DOING SO, THE TRAILER STRUCK A CONCRETE POLE CAUSING THE TANK TRAILER TO BECOME COMPROMISED. APPROXIMATELY 1465 GALLONS OF DIESEL FUEL WAS RELEASED. A PORTION OF THE SPILLED DIESEL FUEL WAS ABLE TO MIGRATE TO A NEARBY STORM DRAIN. H2O ENVIRONMENTAL RESPONDED TO THE SCENE AND HANDLED THE REMEDIATION. NO FURTHER ENVIRONMENTAL IMPACT IS ANTICIPATED.
