FILL HOLE COVER BOLTS WERE LOOSE AND THE FILL HOLE GASKET OUT OF PLACE. A SOUTHERN PACIFIC EMPLOYEE WAS CONTAMINATED BY THE PRODUCT DUE TO THE LOOSE FITTINGS. THE EMPLOYEE WAS TREATED AND RELEASED FOR CHEMICAL BURNS TO THE BACK AREA AND THE RIGHT ARM. REPAIRS WERE MADE BY RE-POSITIONING THE FILL HOLE GASKET AND PROPERLY SECURING THE FILL HOLE COVER PLATE. THE FREE LIQUID ON TOP OF THE TANK CAR WAS NEUTRALIZED. THE CAR WAS THEN SPOTTED TO THE INDUSTRY FOR COMPLETE DE-CON.
