THE INCIDENT OCCURRED 26 JULY 2001 DURING UNLOADING OF FUEL OIL FROM THE CARRIER'S TANK TRAILER TO THE CONSIGNEE'S FUEL OIL STORAGE TANKS. THE UNLOADING OF FUEL AT THIS FACILITY UTILIZES THE FACILITY'S FUEL PUMPS, WHICH ARE FED BY GRAVITY FROM THE DELIVERY VEHICLE. ELECTRICAL MALFUNCTIONS IN THE DELIVERY SYSTEM CAUSED THE DELIVERY PUMP TO SHUT DOWN, UNBEKNOWNST TO THE DRIVER. THE DESIGN OF THE DELIVERY SYSTEM PIPING ALLOWED FUEL TO SIPHON FROM THE TANK TRAILER AND DISCHARGE VIA A VENT INTO THE UNDERGROUND PUMP VAULT, WHICH WAS NOT VISIBLE TO THE DRIVER. EFFORTS TO START THE PUMP FAILED AS THE VAULT FLOODED AND SHORTED THE MOTOR. FUEL ESCAPED IN THE SURROUNDING SOIL THROUGH HOLES IN THE VAULT. UPON DISCOVERY OF THE SPILL, THE DRIVER SECURED HIS TANK. CONSIGNEE TOOK IMMEDIATE ACTION TO RECOVER THE REMAINING FUEL IN THE VAULT (APPROX. 1900 GALLONS) THEN HIRED A REMEDIATION CONTRACTOR TO ADDRESS SOIL AND GROUND WATER IMPACTS. CONSIGNEE COMPLETED UPGRADES TO THE FUEL DELIVERY SYSTEM TO PREVENT A RECURRENCE, HAS SINCE CEASED OPERATIONS.
