THE TRACTOR-TRAILER LEFT THE ROADWAY AT APPROXIMATELY 12:01 AM ON 12-03-99, THE TRACTOR-TRAILER ROLLED OVER. THE TRAILER WAS LOADED WITH ARGON, REFRIGERATE LIQUID, WHICH IS A NON-FLAMMABLE, NO-HAZARDOUS SUBSTANCE. THE ROLL OVER CAUSED A LIQUID VAPOR RELEASE OF PRODUCT OUT OF THE TRAILER VENT STACK. THIS WAS DUE TO THE TRAILER BEING ON ITS SIDE, PUTTING LIQUID DIRECTLY INTO THE VENT SYSTEM. APPROXIMATELY 200,000 CU FT. OF PRODUCT LOST TO THE ATMOSPHERE, THE REMAINING PRODUCT WAS RECOVERED BY TRANSFERRING TO ANOTHER TRAILER. A MINOR SPILL OF DIESEL FUEL AND MOTOR OIL WAS PROMPTLY CLEANED UP BY FERGUSON & HARBOUR CO, WHICH IS A HAZARDOUS RESPONSE CO. THIS ACCIDENT OCCURRED NORTH OF THE 257 MILE MARKER ON I-55. THE TRACTOR-TRAILER UNIT WAS NORTH BOUND BOTH DRIVERS WERE TAKEN BY AMBULANCE TO THE ELVIS PRESLEY TRAUMA CENTER IN MEMPHIS, TENNESSEE. BOTH DRIVERS SUSTAINED MULTIPLE CUTS & CONTUSIONS TO THE BODY. INFORMATION ON THIS ACCIDENT WAS SENT TO ALL OF OUR TERMINALS TO BE DISCUSSED IN DETAIL.
