A TANK TRAILER LOADED WITH SODIUM HYDROXIDE SOLUTION WAS NOT PROPERLY CLOSED AT THE DOME LID. THE LOAD WAS AN INTRA-PLANT MOVE, DESTINED FOR ANOTHER PART OF THE SHIPPER'S PLANT. APPROXIMATELY 200 GALLONS OF PRODUCT SLOSHED FROM THE DOME LID ONTO VARIOUS DRIVEWAYS AND THE STREET, UNTIL THE DRIVER WAS NOTIFIED OF THE SPILL. A QUALIFIED CLEAN-UP CONTRACTOR WAS CALLED TO NEUTRALIZE AND PICK-UP THE SPILL. THE WASTE WAS PROPERLY DISPOSED. THE DRIVER WAS DISCIPLINED FOR FAILING TO SECURE THE LOAD.
