When the cap finally popped off, the liquid released splashing on the employee wrist and hand. The liquid ran down into his glove cuff. The employee sustained a 1st and 2nd degree freeze burn to left hand. The employee was seen in the E/R and was discharged. He was given silvadene cream and dressing. The employee missed work from 2/11/2016 through 2/18/16. He has returned to work.
