THE COLLISION WITH THE OTHER VEHICLE CAUSED DAMAGE TO THE BUCKET BOX WHICH KNOCKED A LIQUID PIPE LOOSE CAUSING PRODUCT TO LEAK OUT. THE DRIVER WAS ABLE TO SHUT OFF THE VALVE TO STOP THE LEAK. ALL PRODUCT PRODUCT DISSAPATED INTO THE AIR. NO TOXICOLOGIAL OR ENVIRONMENTAL DAMAGE.
