FACILITY WAS EVACUATED AND APPROPRIATE AUTHORITIES CALLED HARCROS CHEMICALS OF MEMPHIS PUT THE CYLINDER IN A CONTAINMENT VESSEL AND REMOVED IT TO THEIR FACILITY IN MEMPHIS. THAT IS THE REASON WE HAVE NO SERIAL NUMBER OR DATES OF THE CYLINDER. ACTION TAKEN TO PREVENT FUTURE INCIDENTS. WE NO LONGER HANDLE AND CHLORINE OR OTHER TOXIC GASES.
