AS THE DRIVER WAS TRAVELING N. ON I-25 HE APPEARED TO BE HAVING SOME TYPE OF HEALTH ISSUES – I.E; HEART ATTACK. THE DRIVER AS A RESULT OF THIS RAN OFF ROAD ON RIGHT/EAST SIDE AND TRAVELED DOWN A SMALL BANK. THE DRIVER TRIED TO STEER LEFT BACK ONTO ROADWAY BUT OVERTURNED IN THE PROCESS AS HE WAS TRAVELING UP THE EMBANKMENT. THE DRIVER DIED AT THE SCENE OF ACCIDENT. THE TANK HAD TWO SMALL HOLES; BOTH WERE PLUGGED AND SECURED SHORTLY AFTER THE ACCIDENT. SAND WAS PUT DOWN ON THE ROADWAY ALONG WITH A SAND BARRIER TO HOLD THE POOL OF DIESEL FUEL TO ONE AREA.
