TRACTOR-TRAILER PROCEEDING NORTH ON RT. 601. WEATHER WAS HAZY WITH A MISTING RAIN. STOPPED AT RAILROAD TRACKS AT WHICH TIME THE WARNING LIGHTS WERE BLINKING. THE LIGHTS THEN STOPPED BLINKING, THEN STARTED AGAIN. THE DRIVER LOOKED BOTH WAYS AND SAW NO TRAIN, HOWEVER HE DID SEE WHAT HE BELIEVED TO BE A CREW WORKING ON THE TRACKS. BELIEVING THE CREW HAD SOMETHING TO DO WITH THE LIGHTS, THE DRIVER PROCEEDED TO CROSS THE TRACKS. WHEN NEARLY COMPLETELY ACROSS THE TRACKS, THE DRIVER HEARD THE TRAIN HORN BLAST, WITH IMPACT ALMOST IMMEDIATELY FOLLOWING. THE TRAIN PUT A HOLE APPROXIMATELY 4 INCHES IN THE BACK END OF THE TRAILER WITH THE IMPACT CAUSING THE TRACTOR-TRAILER TO ROLL ON ITS SIDE. SPILL WAS IMMEDIATELY HANDLED BY S.C. DHEC AND AREA EMERGENCY CREWS. OHM CORPORATION, A CLEAN-UP CONTRACTOR, WAS BROUGHT IN BY CARRIER TO HANDLE THE CLEAN-UP.
