REPUBLIC REFINING USES AN AUTOMATED SCALE LOADING SYSTEM. THE SYSTEM CUTS OFF THE LOADING VALVE WHEN A PRE-SET GROSS WEIGHT IS REACHED. DSI DRIVER MITCHELL TURNER SPOTTED HIS TRACTOR/TRAILER ON THE SCALES WITH ONE STEERING TIRE JUSTS LIGHTLY OFF THE SCALE. THIS GAVE A FALSE READING, THUS THE LOADING VALVE DID NOT SHUT OFF. THE TANK OVERFILLED; DRIVER TURNER MANUALLY CUT THE FLOW OFF. APPROXIMATELY 3200 LBS. OF SULFUR SPILLED. THE MATERIAL SOLIDIFIED ON CONCRETE AND WAS CLEANED UP. THE SOLID MATERIAL WILL BE REMELTED AND USED AGAIN. THIS DRIVER WAS RETAINED IN ORDER TO PREVENT FUTURE INCIDENTS.
