THE KAG WEST, LLC DRIVER WAS ATTEMPTING TO LOAD RENEWABLE DIESEL FUEL INTO THE TANK TRAILER AT THE SHIPPER'S LOADING FACILITY IN KINGMAN, ARIZONA. AFTER LOADING AN ESTIMATE 100-200 GALLONS OF RENEWABLE DIESEL FUEL THERE WAS A SUDDEN EXPLOSION NEAR THE SHIPPER'S LOADING LINES. THE INITIAL THEORY AS TO THE CAUSE OF THE EXPLOSION IS A BUILD-UP OF STATIC ELECTRICITY IN THE SHIPPER'S LOADING LINES. AS A RESULT OF THE EXPLOSION AND FIRE, THE KAG WEST, LLC TRACTOR AND TANK TRAILER WERE COMPLETELY CONSUMED ALONG WITH THE SHIPPER'S LOADING FACILITIES. THE SHIPPER WAS UNABLE TO IMMEDIATELY STOP THE FLOW OF RENEWABLE DIESEL FUEL FROM THE LOADING LINES AND THE FIRE DEPARTMENT ESTIMATES THAT A TOTAL OF 20,000 GALLONS WAS RELEASED/CONSUMED BY FIRE. THE SHIPPER CONTACTED H2O ENVIRONMENTAL TO RESPOND TO THE SCENE AND HANDLE THE REMEDIATION.
