Describe:

The event occurred while loading an MC-331 with Anhydrous Ammonia. Previously, valves had been opened, sending vapor pressure to the flare. Due to operator error, the valve to the flare was left open. A second valve was misaligned allowing liquid to collect in the flare line.

Liquid traveled to the flare and overwhelmed the flare, allowing ammonia vapors to be released.

The vapor release was noticed almost immediately by a supervisor. The valves were identified and the release was stopped in less than 10 minutes. The total estimated release was 240 gallons.
