OUR VEHICLE WAS AT CONSIGNEE LOCATION TO DELIVER 440 GALLONS OF SULFURIC ACID (VIA 2 220 GALLON IBC'S) TO A TANK AT THE INDUSTRIAL WASTE WATER TREATMENT PLANT. A PVC FITTING USED IN THE UNLOADING PROCESS FAILED, RESULTING IN THE RELEASE. THE IBC DID NOT FAIL. THE SPILLED MATERIAL WAS CLEANED UP BY MCCUTCHEON ENTERPRISES, INC. OF APOLLO, PA (LOCAL ENVIRONMENTAL SPILL RESPONSE CONTRACTOR). THE FILLING IS NOW MADE OF METAL. THERE WERE NO INJURIES.
