UNIT 1 WAS TRAVELING NORTH ON US 81 TOWING UNIT 2. UNIT 1 WAS TRAVELING IN THE INSIDE LAND AND WITNESSES STATED THAT UNIT 3 WAS IN THE OUTSIDE LAND TRAVELING NORTH. WITNESS STATED THAT AS THE UNITS STARTED AROUND THE CURVE UNIT 3 VEERED INTO UNIT 1 AND UNIT 2'S LANE. UNIT 1 DRIVER WAS ABLE TO AVOID A COLLISION WITH UNIT 3, BUT WAS UNABLE TO CORRECT THE EVASIVE ACTION THAT WAS TAKEN. UNIT 1 STRUCK THE GUARD RAIL AND SLID ON ITS SIDE COMING TO A STOP FACING NORTH. THE WITNESS STATE THAT UNIT 3 CONTINUED ON WITHOUT STOPPING. THE WITNESS WAS UNABLE TO GIVE A DESCRIPTION OF UNIT 3, OTHER THAN IT WAS A RED PASSENGER CAR. COMMERCIAL VEHICLE INSPECTORS WERE CONTACTED AND COMPLETED AN INSPECTION. ENVIRONMENTAL CLEAN UP BY TAS ENVIRONMENTAL.
