THE SHERRIFF DEPARTMENT DEEMED THIS AS AN ACCIDENTAL FIRE. AN EMERGENCY RESPONSE TEAM CONTAINED AND CLEANED UP THE INCIDENT. ALL 5 SKIDS OF BATTERIES WERE A TOTAL LOSS. NO INJURIES
