THE DRIVER OF A TRANSPORT TANKER CARRYING ETHANOL OVERTURNED ON INTERSTATE 35 NEAR GUTHRIE OK. IT WAS RAINING AND THE DRIVER TOOK EYES OFF ROAD WAY AND THEN OVER CORRECTED WHEN HE WAS LEAVING ROAD WAY CAUSING IT TO OVERTURN. A SMALL VALVE APPROXIMATELY 1/2 INCH WAS TORN OFF FROM THE BOTTOM OF THE TANK RELEASING THE ETHANOL. ALSO THE 5 FILL PORTS FORM THE TOP OF THE TANKER WERE LEAKING AS WELL. THE 1/2 VALVE WAS PLUGGED BY FIRE DEPARTMENT. IT WAS ESTIMATED 250 GALLONS WAS LOST. RESPONSE TEAM TRANSFERRED THE REMAINING PRODUCT.
