CARRIER PERSONNEL NOTED WHITE POWDERY SUBSTANCE IN GAUGE OF TRACK OVER A 22 MILE AREA. INVESTIGATION REVEALED THAT BN 449959 WHICH HAD ALREADY BEEN SPOTTED AT THE CONSIGNEE'S SIDING, HAD 3 DOOR SPARTIALLY OPEN ALLOWING CONTENTS TO LEAK FROM CAR. AREAS WHERE CAR HAD PREVIOUSLY MOVED AND BEEN STORED CHECKED WITH NO INDICATION OF LEAKAGE NOTED. SHIPPER ADVISED CAR HAS BEEN INSPECTED AND HOPPER DOORS SECURELY CLOSED AND FASTENED WITH SECURITY SEALS PRIOR TO DEPARTURE FROM ORIGIN. LEAKAGE APPARENTLY DUE TO VANDALISM. SPILLED MATERIAL RECOVERED AND RETURNED TO CONSIGNEE FOR DISPOSAL.
