UNIT #1 WAS EXITING SOUTHBOUND OFF I-380 ONTO WESTBOUND I-80. WHEN #1 ENTERED THE EXIT RAMP THAT LEADS FROM I-380 TO I-80, UNIT #1 ROLLED OVER TOWARDS THE LEFT. THE RAMP IS A CURVE TYPE RAMP AND THE CURVE TIGHTENS AS A VEHICLE GOES FURTHER INTO THE CURVE. #1 WENT ONTO THE LEFT SHOULDER OF THE CURVE WHICH SLOPES AWAY FROM THE ROADWAY. WHEN THE UNIT GOT ONTO THE SHOULDER THE DRIVER TRIED TO BRING THE UNIT BACK ONTO THE ROADWAY BY STEERING TO THE RIGHT WHICH CAUSED THE ENTIRE UNIT TO ROLL OVER TOWARDS THE LEFT. THE REAR PORTION TO THE TRACTORS FRAME RAIL PUSHED UP THROUGH THE BOTTOM PART OF THE BARREL ON THE CARGO TANK, PUNCTURING A 5" HOLE THROUGH THE BARREL. WHEN THE UNIT CAME TO REST, ON ITS RIGHT SIDE NOTHING WAS LEAKING FROM ANY PART OF THE TRAILER OTHER THAN THE HOLE PUNCHED THROUGH BY THE FRAME RAIL. 587 GALLONS OF PRODUCT LEAKED OUT PRIOR TO UNIT BEING LIFTED OUT.
