ON DECEMBER 31, 2004, AT APPROXIMATELY 09:30 HOURS, RAILWAY CAR IAPX 1015 CONTAINING ARGON, REFRIGERATED LIQUID, 2.2., UN1951, WAS REPORTED LEAKING WHILE BEING SWITCHED AT THE KANSAS CITY, MISSOURI, KANSAS CITY SOUTHERN RAILWAY (KCSR) RAIL YARD. A SHIPPER REPRESENTATIVE RESPONDED TO THE SITE AND FOUND TWO OF TWO PACKING GLAND NUTS ON PURGE VALVE MISSING. AN OPEN LIQUID VALVE WAS ALSO FEEDING THE PURGE VALVE. THE SHIPPER REPLACED THE PACKING GLAND NUTS AND CORRECTED THE OPEN VALVE. THERE WERE NO INJURIES, NO DAMAGE TO THE ENVIRONMENT, AND THE TANK CAR WAS RELEASED FOR DESTINATION. OPEN LIQUID VALVE; TWO OF TWO PACKING GLAN NUTS ON PURGE VALVE MISSING.
