AFTER INITIAL REPORTS OF AIRBORNE LEAKAGE, CLOSE INSPECTION REVEALED A VISIBLE VAPOR LEAK IN THE AREA WHERE THE TANK CAR'S GAUGING DEVICE WAS SUPPOSED TO BE. IN PLACE OF THIS GAUGING DEVICE, A ROUND FLANGE PLATE WAS FOUND, SECURED WITH 4 NUTS AND A VISIBLE OPENING BELOW ONE AREA OF THE PLATE. IT APPEARS THAT SA SPLIT "O" RING UNDERNEATH THIS FLANGE PLATE WAS THE SOURCE OF LEAKAGE. ER CONTRACTORS WERE HIRED TO INSTALL A CAPPING-KIT (C-KIT). AFTER 4 DAYS OF VARIOUS METHODS OF CAPPING, PRESSURE REDUCTION AND TRANSFER COMBINATIONS, A STANDARD C-KIT WAS MODIFIED (IN ADDITION TO SOME STEEL REMOVAL IN THE VERY TIGHT DOME AREA) AND PROVED TO BE SUCCESSFUL IN CAPPING THE LEAK. *NOTE AS PER ITEM 2, TIME WAS APPROXIMATE. *NOTE AS PER ITEM 26, CPR BELIEVES THAT THE CAR WAS NOT IN A "TRANSPORTATION PHASE" AS WE WERE AWAITING WORD FROM THE CONSIGNEE AS TO DELIVERY. *NOTE AS PER ITEM 35, PACKAGING MARKINGS ARE: DOT 105 J 340 W. SAFETY VALVE: 247.5 PSI; TESTED: 2000. DUE: 2005. TANK PRESSURE: 300 PSI. TESTED: 2000. DUE: 2010. BUILT: 8-87. *NOTE AS PER ITEM 39, PART B, CPR HAS NOW HEARD CAR HAD BEEN MODIFIED, NOT BY CPR.
