OUR VEHICLE EXPERIENCED A FIRE OF YET UNKNOWN ORIGIN. THE GENERAL AREA WAS EVACUATED. THE TRUCK WAS DIKED WITH SAND BEFORE THE FIRE WAS EXTINGUISHED.
