AT APPROXIMATELY 12:15 AM, JUNE 27, 1987, TRAIN 6/TC-4, LOCOMOTIVES NS 3321, 6149 AND 1633, 73 LOADS AND 31 EMPTIES, 35 MPH, DERAILED THE 33RD THROUGH 66TH LEAD CARS AT MP 408.5, RIVERTON, ILLINOIS. CAR TTX 476653, LOAD OF 55 GALLONS OF JET TURBINE FUEL IN CONTAINER SEAU 453207, WAS THE 49TH HEAD CAR OR THE 17TH CAR TO DERAIL, DAMAGING 9 DRUMS. THERE WAS APPROXIMATELY 200 GALLONS OF JET FUEL LOST, WHICH WAS CONTAINED BY THE CITY OF RIVERTON FIRE DEPARTMENT AND N & W ENVIRONMENTAL PROTECTION FORCES. THE NATIONAL RESPONSE CENTER, NTSB, DOT, EPA, ICC AND FRA WERE NOTIFIED. IN THE PROCESS OF TRANSFERRING THE LADING FROM THE DERAILED CARS ON JUNE 30, 1987 AT APPROXIMATELY 10:05 PM, THREE (3) MIDWEST COMMODITIES EMPLOYEES RECEIVED CHEMICAL BURNS AND SKIN IRRITATIONS. ONE DECLINED MEDICAL ATTENTION AND TWO WERE TAKEN TO MEMORIAL MEDICAL CENTER IN SPRINGFIELD, ILLINOIS AND ADMITTED FOR TREATMENT. IT IS SUSPICIONED THAT THESE INJURIES RESULT FROM THE JET FUEL; HOWEVER, THERE WERE OTHER NON-REGULATED CHEMICALS IN THE DERAILMENT WHICH MAY HAVE BEEN INVOLVED IN THESE INJURIES.
