DRIVER OF UNIT, DRIVING WEST ON I 64 IN CHARLESTON W VA. APPARENTLY BLACKED OUT & LOST CONTROL OF THE UNIT. THE UNIT (TRACTOR-TRAILER) TRAVELED TO THE SOUTH (LEFT) SIDE. OF I-64 WEST. STRIKING THE LEFT BARRIER WALL SKIDDING ALONG WALL BEFORE GOING OVER THE BARRIER INTO THE GAP BETWEEN THE EAST AND WEST BOUND OVERPASS, ENDING UP 30' BELOW THE BRIDGE. THE TRACTOR SEPARATED FROM THE TANKER WHEN THE FRONT OF THE TRAILER STRUCK THE SUPPORT BEAM WHICH CORNERS EAST & WEST BOUND LANES, THE TANKER RUPTURED WHEN IT HIT THE SUPPORT BEAMS AND THEN FELL APPROXIMATELY 30' TO THE GROUND UNDER BRIDGE. THE TRAILER LANDED ON THE TOP REAR AND RUPTURED THE REAR, OF THE TRAILER. ICI EXPLOSIVES DISPATCHED EMERGENCY RESPONSE TEAMS FOR CONTAINMENT AND CLEAN UP THE AREA.
