LOAD WAS TRANSFERRED FROM LEAKING VESSEL TO LINED TANKER. THE MATERIAL WHICH SPILLED ONTO THE GROUND WAS NEUTRALIZED AND OUR DRIVER LEFT THE SCENE WITH THE EMPTY VESSEL. ALL OF OUR TANK VANS HAVE BEEN PLACED OUT OF SERVICE UNTIL A THOROUGH EXAMINATION IS PERFORMED TO OUR SATISFACTION THAT THEY ARE ROAD WORTHY. THE MANUFACTURER IS COMING TO OUR LOCATION WITH A TEAM TO INVESTIGATE.
