ACFX 88705 INVOLVED IN 7 CAR DERAILMENT. CAR WAS OFF THE WHEELS AND LEANING AT APPX 45 DEGREES. ABOUT 15 GALLONS OF PRODUCT WAS RELEASED DUE TO THE RUPTURED DISC. 7 GALLONS WAS CAPTURED AND SOLIDIFIED, REMAINDER WAS NEUTRALIZED ON SITE. SHIPPER REPRESENTATIVES RESPONDED AND REPLACED THE DISC AFTER THE CAR WAS UPRIGHTED AND RERAILED. THE CAR WAS MOVED TO A SAFE LOCATION AND THE CONTENTS TRANSFERRED TO ANOTHER RAILCAR DUE TO DAMAGE TO SAFETY APPLIANCES. CAR HOME SHOPPED FOR FURTHER INSPECTION AND REPAIRS. THE EVACUATION AFFECTED AN ELEMENTARY SCHOOL APPX ONE MILE FROM THE SCENE WHICH WAS DISMISSED EARLY AS A PRECAUTION.
