RAILROAD TANK CAR FMLX 12211 WAS FOUND LEAKING BY SWITCHING CREW AT ABOUT 1630 ON DECEMBER 23, 1991 AT BURLINGTON NORTHERN RAIL YARD LOCATED AT 5401 SHELBY DRIVE, MEMPHIS, TENNESSEE. MEMPHIS, TENNESSEE AND SHELBY COUNTY FIRE DEPARTMENT HAZARDOUS MATERIAL TEAM WAS CALLED AND RESPONDED. IT WAS DETERMINED THAT THE RUBBER LINING OF THE TANK CAR HAD FAILED ALLOWING PRODUCT TO CORRODE THE TANK SHELL SUFFICIENTLY TO LEAK. THE EXACT LOCATION OF LEAK COULD NOT BE DETERMINED DUE TO BEING CONCEALED BY TANK JACKET. LEAKAGE WAS COMING FROM BOTTOM OF JACKET AT THREE DIFFERENT LOCATIONS, AT EACH END AROUND THE STUB SILLS AND AROUND THE OUTLET NOZZLE AT THE BOTTOM CENTER OF TANK. THE LADING REMAINING IN THE CAR WAS TRANSFERRED INTO TANKER TRUCKS AND THE PRODUCT THAT HAD SPILLED ONTO GROUND UNDER THE CAR WAS NEUTRALIZED USING SODA ASH.
