Unknown party drove into dispensing unit on 1,000 gallon ASME stationary tank located at KOA Campground, shearing liquid withdrawal valve, and causing a leak. Accident occurred at 0400 and release stopped at 0900. Gas was dispersed to atmosphere, with no fire or explosion. 8 people staying at camp site evacuated for a period of 4 hours.
