WHILE UNLOADING, ONE DAMAGED 250 GALLON PLASTIC DRUM WAS DISCOVERED AT THE 3/4 MARK OF THE TRAILER. APPROXIMATELY 125 GALLONS OF FREE PRODUCT WERE RELEASED. APPARENTLY THE DAMAGE TO THE DRUM WAS DUE TO A PUNCTURE BY A FORKLIFT. THE TERMINAL HAZMAT TEAM PERFORMED THE CLEANUP USING LEVEL C PROTECTION. THE CLEANUP MATERIALS WERE PLACED INTO TWO 55 GALLON PLASTIC RECOVERY DRUMS AND TWO 85 GALLON PLASTIC RECOVERY DRUMS. THE RECOVERY DRUMS WILL BE HELD AT THE TERMINAL FOR DISPOSITION. THE DAMAGED DRUM WILL BE WIPED OFF AND SENT BACK TO THE SHIPPER. THE REMAINDER OF THE SHIPMENT WILL BE FORWARDED TO THE CONSIGNEE. NO INJURIES OR EXPOSURES WERE REPORTED. THE MSDS WAS REQUESTED AND RECEIVED.
