12-26-12 Upon arrival at the facility, a transfer from the railcar to an on-site storage tank was initiated. During the transfer, a tankwagon was being loaded in the same vicinity as the unloading process. At the completion of filling the tankwagon, the operator was going up the stairs to button up the tankwagon. At this point, he witnessed ferric starting to leak out of the rail car between our fitting and the fitting on the car. He shut down the transfer and released the air pressure on the railcar. He then C clamp on the fittings to slow down the leak. He then re-tightened the bolts on the fittings to stop the leak. A call to the company incident commander was then initiated. Duration of the release was approximately 5 minutes. During the investigation, it was discovered that a tear had occurred on the gasket.
